**Minimum requirements for acceptance:**

- 2.0 GPA (unweighted) in grades 6-8; no grades of “F.”
- No Level I or Level II discipline referrals
- Good attendance record. Absences beyond the State policy limits are not acceptable.
- An expressed interest in early childhood education
- If you have scores of less than 3 on FCAT Reading and/or Math, you may be required to take remedial courses in those areas. This may keep you from having room in your schedule to take Academy classes. Please check with your Guidance Counselor.

Please deliver teacher recommendation forms to your math, language arts, and technology teachers. Also please ask your school guidance counselor to forward your transcript directly to the Academy director as soon as grades have been posted at the end of 1<sup>st</sup> semester of the current school year.

*This application process does not guarantee admission to the early Childhood Education program. Applicants will be chosen based on the above criteria as well as current District policies.*

**Requirements to Remain in the Academy:**

- Maintain a minimum unweighted cumulative GPA of 2.0 and no grade lower than a “C” in Academy courses. No grades of “F.”
- Demonstrate exemplary conduct with no discipline referrals of Level I or Level II.
- Maintain a good attendance record, meeting attendance criteria established by State and District policy.

**If you are attending on a zoning exemption:**

- Your school zoning exemption may be revoked if you accrue one or more Level I or II discipline referrals within the school year, or if you accrue three or more lesser offenses.
- The zoning exemption may also be revoked if you accrue six or more unexcused absences within a school year, or ten or more tardies within a school year.
- Your zoning exemption will be revoked if you do not register for an Academy class each year.
